CALL TO ORDER:

Mayor Retzer called the meeting to order at 7:00 p.m.

GOOD OF THE CITY:

Golden reminded candidate filing for open council positions starts May 5th. Golden went on to say he will be running for another term.

CITIZENS REQUEST:

Dennis and Diane Solbrack-

Dennis and Diane Solbrack 510 W Moller Road, Colfax, sent a new proposal to the city requesting another look at building a 20' street on the 40' platted Ann Street. The Solbracks' are proposing a 20' wide non-conforming paved street that includes clearance for height of fire trucks. This proposal will go around existing structures without harm and provides needed setback requirements and will be built to city standards. Solbracks have hired an engineer firm and will have a traffic study done.

Benefits of this 20' non-conforming street are:

- Matches the width of the available street on Orchard.
- Minimizes any potential problems with neighbors' property
- Provides the ability to get title insurance
- This does not require removal of existing structures and will allow access to Gass' building and Krikac lots. Does not require removal of existing fences or embankments
- This minimizes any potential issue with water drainage to properties below the street
- This proposal leaves the door open for future improvement of the non-conforming street

Hammer stated the traveled portion is not all on city right of way, so there will need to be property line adjustments if built on the traveled portion. The street can be built without neighbors' agreement or property line adjustments, it would just take a lot more construction for the Solbracks and would be built on platted Ann Street.

Before the Solbracks approach the neighbors, they asked for something in writing from the city that gives them the go ahead to move forward with building a city street. Solbrack stated they think it is in the best interest of everyone to stay on the traveled way, but they can build the street on the right of way if needed.

The consensus of the council; they are in support of new plan, they asked for an engineered to city standard street and the Solbracks are working towards that.

Building and Community Development Shawn McSweeney will send out notification to neighbors within 300 feet of proposed roadway work and boundary line adjustment if needed.

Hammer stated there will need to be a SEPA completed and there will be several times for public comment during this process.

A motion was entered by Guenthner, seconded by Sevedge to pass Resolution 25-08 agreeing to the preliminary plans for the Solbrack road construction. Roll Call: All Yes.

DEPARTMENT REPORTS:

Public Works:

Public Works continues to work on replacing water meters with the new remote readers.

Hammer stated the water meter has been installed at the airport for the Port of Whitman water right agreement, they will be charged for basic usage and then anything over 5,000 gallons a day.

Hammer will meet with FEMA, Corp of Engineer and the Department of Ecology this week.

Fire:

Firefighter David Buckley stated they are starting to receive the upgraded air packs.

Police:

Mayor Retzer reported five interviewed for the police entry level position, four were sent off to start the background process. Retzer heard today that one of the applicants has already accepted an offer with another agency.

The city was able to purchase a 2017 Ford Explorer for the police at a very good price.

COMMITTEE/BOARD/COMISSION REPORTS:

Greenway Update- Blaine Golden-

Golden spoke about the feasibility study for the Colfax Greenway Path. The study was paid for by private funding after the groups attempt at a grant was unsuccessful. The study identified the current state of the rails and what the path could look like. The study displays a "cadillac plan" and comes in at an estimated 3.2 million, this can be scaled back to varying degrees and also be a work in progress as funds come available. Golden stated rail banking could be an option, if the rails were removed, allowing for interim use as a trail and land would be preserved if the rails would ever need to go back in.
