UNFINISHED BUSINESS:

Ann Street Discussion:

City Administrator Matt Hammer was updated by the fire department that the International Fire Code (IFC) minimum road width requirement is 20 feet, with a required turning radius of 35-foot minimum inside and 55-foot minimum outside. This information has been provided to Solbrack.

Tom Stirling of SynTier Engineering, who has been working with the Solbracks, has made the turns onto Ann Street to accommodate a 43 ft. truck. Stirling stated that achieving a 20 ft street with a 20 ft right of way is nearly impossible given the slope of the hill, without impacting neighboring property owners. He noted that ideally, one side of the area would be over-dug to increase the street width, but neighboring properties do not permit this. With the necessary retaining walls to hold the hillsides, Stirling estimates that the "Old Orchard" portion will ultimately be 19 ft. wide for approximately 250 feet of the 1700 ft street. Stirling also informed the council that drainage from the new street will be directed into a basin to prevent runoff onto abutting properties.

Current city code for street build is 32 ft. When the resolution was approved, we were well below that. The resolution was to explore the feasibility of building a 20 ft road all the way through, not an approval to build.

The council has the following requests and concerns:

- What is the city's liability if we do not follow the IFC guidelines
- Escape routes from the Solbrack property.
- Width deviating from the previously passed resolution for a 20 ft non-conforming street.
- Narrower street could impede emergency response to this area.
- Fire department to meet with Tom Stirling regarding the width and code requirements.
- Written report from the fire department to determine the appropriate width for apparatus.
