## REQUIRED BUILDING INSPECTIONS

**It is the duty of the building permit holder or their duly authorized agent to notify the building inspector when work is ready for inspection. The permit holder must provide access to and means for inspections that are required by ICC code.**

**Work shall not proceed beyond the point indicated in each successive inspection without first obtaining the approval of the building inspector. Any portions that do not comply shall be corrected and such portion shall not be covered or concealed until authorized by the building inspector.**

- \_\_\_\_\_ **Exterior Water & Sewer:** Made at any time during construction when the piping and bedding is complete and tracer wire is in place when using non-metallic piping and, when required, the back flow valve is installed.
  
- \_\_\_\_\_ **Rough-in Plumbing:** Made when all water piping, drain, waste and vent lines have been installed and under test, prior to covering.
  
- \_\_\_\_\_ **Gas Piping:** Made when gas piping has been installed and approved prior to connection by utility company.
  
- \_\_\_\_\_ **Gas Appliances:** When gas appliances are set, venting installed and gas piping has been tested and approved.
  
- \_\_\_\_\_ **Final Inspection:** Final inspection is made when the structure is complete and ready to be occupied, attic and floor insulation installed, final grading, parking pads/lots, driveways and sidewalks have been completed, the final electrical approved and when required, another departmental approvals have been completed.
