#### SECTION 5: TERMS AND REGULATIONS

##### IF EXCAVATING STREET OR SIDEWALK, THE FOLLOWING TERMS APPLY

Any applicant who obtains a street/sidewalk excavation/obstruction permit shall assume complete financial responsibility to restore the street, alley, sidewalk, highway or other public place to its original aesthetic and structural condition by the time of permit expiration. Once the street, sidewalk, alley, highway or other public place is restored to its original condition, the deposit will be refunded to the applicant.

If restoration of the affected sidewalk, paving or surface is not accomplished by the permit holder, the City of Colfax will perform all work and things necessary to clear or restore the street, alley, sidewalk, highway or other public place to its original and proper condition, and the applicant named in this permit shall be liable for the expenses thereof. If the deposit is in excess of the actual cost, that amount will be refunded.

If any section of restored street/sidewalk fails within a time period of one year, the applicant shall be responsible for repairing such portion/s of street and/or sidewalk. A street/sidewalk failure may include, but is not limited to settlement caused by lack of compaction, potholes, rutting, and cracking. Upon discovery of a failed street/sidewalk the City shall notify the applicant. The applicant shall have 15 days to respond to the city with a plan and timeline for repair. If the applicant does not contact the city within the 15 day period, or refuses to make repairs, the City may repair the failed street/sidewalk, and shall hold the applicant responsible for any associated costs.

The applicant will indemnify and hold harmless the city from any and all claims, liability, judgements, costs, damages and expenses arising from any acts which he may do or suffer to be done in the execution of the work allowed by this permit or any liability or suffer to be done in the execution of the work allowed by this permit or any liability arising from negligence on his part or the part of his agents in obstructing or in any way disturbing the street, alley, highway, sidewalk, or other public place. The applicant shall be responsible to sufficiently mark the site of excavation to maintain public safety. **THE CITY SHALL BE NOTIFIED BEFORE ACTUAL EXCAVATION BEGINS.**
