# **SIGN PERMIT PROCEDURE**

## **SUBMITTAL REQUIREMENTS**

1. A completed "SIGN PERMIT APPLICATION", including legal description\* (one application for each sign).
2. For all FREESTANDING SIGNS, ROOF SIGNS & PROJECTING SIGNS:
  - A. Construction drawing of the sign bearing the seal of an architect or engineer licensed by the State of Washington verifying that structural members and supports are capable of withstanding all applicable loads  
The Drawing must include:
    - i. HEIGHT of sign
    - ii. DETAILS & DIMENSIONS of all structural and nonstructural members to include sign supports
    - iii. DETAILS & DIMENSIONS of foundations and footing members
    - iv. ADVERTISING AREA of all sign facades
  - B. Complete site drawing TO SCALE that MUST include:
    - i. LOCATION of proposed sign and SETBACK DISTANCES from sign supports to property lines fronting on a street
    - ii. LINEAR FEET street frontage dimensions
    - iii. LOCATIONS of all existing FREESTANDING signs on the same property
    - iv. LOCATIONS of ALL easements and/or utility lines within twenty feet of the proposed sign location
3. For all WALL and AWNING\* SIGNS
  - A. Construction drawing of the sign. The drawing MUST include:
    - i. DETAILS & DIMENSIONS of structural and nonstructural methods of attachment or anchoring to the building
    - ii. ADVERTISING AREA of the sign
  - B. A drawing or photograph of the building façade that MUST include:
    - i. DIMENSIONS of the façade
    - ii. LOCATIONS and SIZES of all other signs on the building.
4. SIGN PERMIT FEE (paid at the time of permit issuance):
  - A. Wall Mounted Sign (\$50)
  - B. Pole Mounted Sign (\$100)
5. Electrical Permits
  - A. Electrical signs must be permitted in accordance with all applicable codes. Please contact the Washington State Department of Labor and Industries regarding electrical permits
